## 交付対象

マイナンバーカードの健康保険証  
利用登録が確認できていない方

※行き違いで、すでにマイナンバーカードの健康保険証  
利用登録をされている場合は、何卒ご容赦ください。

## 2025年(令和7年)12月2日から 従来の健康保険証は使えません

医療機関の窓口で「資格確認書」を提示してください。今まで通り健康保険が使えます。



2025年12月2日以降は、従来の健康保険証の返却は不要です。  
各自で処分をお願いします。

## こんなとき、どうすればいい？

### 退職した・扶養からはずれた

- ▶ 資格確認書を返却

### 氏名に変更があった

- ▶ 資格確認書と「氏名変更届」を提出

### 住所に変更があった

- ▶ 「住所変更届」を提出し、資格確認書の  
住所欄をご自身で新住所に書き換え

### マイナ保険証の登録を行った

- ▶ 資格確認書を返却

### 資格確認書をなくした・き損した

- ▶ 「資格確認書 滅失・き損届」、  
「資格確認書(再)交付申請書」を提出  
き損の場合は、資格確認書を添付

- 手続きは、お勤めの会社のご担当部署を通じてお願いします。任意継続・特例退職の方は健康保険組合へ直接、手続きを行ってください。

- やむを得ない場合を除き、**マイナ保険証をお持ちの方への資格確認書の再交付は行いません。**

# Information on Health Insurance Eligibility Certificates



We have enclosed a Health Insurance Eligibility Certificate as proof of your membership in our Health Insurance Society. Please check the details and handle the certificate with care.

## Eligibility

Those who have not completed the registration to use their My Number Card (Individual Number Card) as a Health Insurance Card.

※If you have already registered your My Number Card as your Health Insurance Card and still receive a Health Insurance Eligibility Certificate due to a timing overlap, we kindly ask for your understanding.

## The existing Health Insurance Card will no longer be valid as of December 2, 2025.

Please present your Health Insurance Eligibility Certificate at the reception desk of medical institutions. You will be able to use your health insurance benefits as usual.



After December 2, 2025, you do not need to return your current Health Insurance Card. Please dispose of it yourself.

## What should I do in the following cases?

### I have retired or am no longer a dependent

- ▶Return your Health Insurance Eligibility Certificate.

### My name has changed

- ▶Submit your Health Insurance Eligibility Certificate along with a Name Change Notification Form.

### My address has changed

- ▶Submit an Address Change Notification Form, and update the address section of your Health Insurance Eligibility Certificate yourself.

### I have registered for a Myna Insurance Card

- ▶Return your Health Insurance Eligibility Certificate.

### I have lost or damaged my Health Insurance Eligibility Certificate

- ▶Submit a Health Insurance Eligibility Certificate Loss/Damage Report Form and a Reissue Application Form for Health Insurance Eligibility Certificate.

If the certificate is damaged, attach the damaged certificate.

- Please complete these procedures through the relevant department at your workplace. If you are continuing your insurance voluntarily or have retired under a special provision, please contact the Health Insurance Society directly.
- Except in unavoidable circumstances, we do not reissue Health Insurance Eligibility Certificates to those who have a Myna Insurance Card.

The Health Insurance Eligibility Certificate has an expiration date. We encourage you to consider switching to a Myna Insurance Card. For information on how to obtain a Myna Insurance Card, please visit the Ministry of Health, Labour and Welfare website.
